COMPONENTS OF THE DIGITAL ECONOMY

- e-business infrastructure (hardware, software, telecoms, networks, human capital, etc.)
- e-business (how business is conducted, any process that an organization conducts over computer related networks)
- e-government (how governments provide services to the public over computed related networks)
- e-commerce (transfer of goods, for example, purchasing a laptop or perfume online)
